1 APOLOGIES

INTERESTS

214 a Dispensation

Cllr Bott left the room for this item and the Vice-chairman took the chair. Cllr Bott had applied to the Council for a dispensation in the matter of the boundary dispute and disposal of the school, as his land adjoined the site. The grounds cited were that it was in the interests of persons living in the Parish Council's area and also that it was otherwise appropriate to grant a dispensation. It was proposed by Cllr Mrs Falconer, seconded by Cllr Mrs Goodworth and agreed unanimously that Cllr Bott be granted a dispensation. Cllr Bott returned to the meeting and resumed the chair.

3 MINUTES OF THE MEETING HELD ON 7 SEPTEMBER 2015

216 It was proposed by Cllr Sparkes, seconded by Cllr Osborne and agreed the minutes of the meeting held on 7th September 2015 be signed as a true record.

217 a C/09/15/11b minute 2015/16/203: Fence at The Herons, Vigo Road, Fariseat

Cllr Mrs Falconer asked that this item be kept on the agenda.

5 STANSTED SCHOOL

218 Cllr Bott said that the Director of Education, Diocese of Rochester, would not be coming after all and had said that all further communication should be through solicitors. Their surveyor had forwarded a Land Registry registration dated 2012, giving title to the Diocese for the land occupied by the buildings and the current playground. This had been equally unexpected by Kent County Council. The surveyor had now been stood down. Cllr Bott was putting all evidence together and the Council's legal adviser would make a submission to the Land Registry. He mentioned the fact that the 2005 extension had been funded by the taxpayer and that KCC was seeking legal advice. Cllr Mrs Falconer said that the Diocese of Rochester Board of Education was separated from the Diocese and was a closed charity. Cllr Bott said he was expecting to have a site meeting with Andrew White of KCC's Property Department.

COUNTY AND BOROUGH COUNCILLORS' REPORTS

The Chairman suspended the meeting to enable the County and Borough Councillors give their reports.

Cllr Mrs Hohler said she had followed up the report of the state left by removal of fixtures at the school. An officer had inspected and had been happy with the removal and that it was up to standard.

Cllr Betts said that as the school had had a policy about bullying, the current situation was ironic. It needed to be pointed out to the Diocese that the costs were likely to fall on them. There was a possibility of setting up a donations fund for residents to protect the community asset. Businesses should be made aware of that the West Kent Leader Fund was taking applications and that funding was available.

Cllr Coffin referred to the enforcement on the Vigo Inn and said that evidence of letting was being sought. The Borough Council was looking at the provision of services through the committee system. The Area Planning Committees had caught attention and would be under scrutiny that week. It was work in progress, no decisions had been made and the letter from East Malling and Larkfield Parish Council was premature. Cllr Brooker commented that the car sales at the Tower Garage on Wrotham Hill were now into the road and the bus stop. Cllr Coffin said there was no planning permission and enforcement was dealing with it.

The Chairman thanked Cllrs Mrs Hohler, Betts and Coffin and reconvened the meeting.

219 i **TM/15/:** Compass Cottage, Malthouse Road, Stansted: Demolition of existing sheds – construction of replacement brick and stone shed

Stansted Parish Council has no objection in principle to this application. However the Parish Council would like to point out that the additional parking as shown on drawing DJH/101 submitted with application TM/10/00186/FL has not yet been provided and considers that a condition should be made that the extra parking is provided before any demolition and construction takes place, in the interests of road safety and minimising on-street parking
