### 3 MINUTES OF THE MEETING HELD ON 8 JANUARY 2017

360 It was proposed by Cllr Osborne, seconded by Cllr Sefer and agreed the minutes of the meeting held on 8<sup>th</sup> January 2018 be signed as a true record.

# 5 CASUAL VACANCY

362 The casual vacancy had been reported to Tonbridge & Malling Borough Council and the statutory notices had been put up. The closing date for electors to call an election was midnight on Wednesday 14<sup>th</sup> February.

The Chairman suspended the meeting to allow Cllrs Rayner, Betts and Coffin to speak.

Cllr Rayner said it was expected Kent County Council would raise its precept by 2%, plus 2% for social services. The County Council would be a partner with West Kent Consortium concerning waste to get the best results.

Cllr Coffin said that the Borough Council was allowed to raise its precept by 3%. Stansted would have the lowest Borough precept. Waste collection was up for a new contract and it would include an improvement in services. Cllr Betts reported on the plan to create a smart motorway on the M20 between junctions 3 and 5, with use of the hard shoulder.

The Chairman thanked the County and Borough Councillors and reconvened the meeting.

# 6 STANSTED SCHOOL

The Chairman suspended the meeting to allow Tom Sheldon to speak.

### 363 a Steering Group Update

Mr Sheldon said the Steering Group was busy working on a cash flow. They were also exploring the possibilities of letting the school out to any other educational establishments.

### 364 b Contract

Mr Sheldon said it had been hoped the contract would be ready for signing that evening but there were still a few points to clarify in the negotiations. The draft contract had been with the vendor's solicitor for the past ten days.

The Chairman thanked Mr Sheldon and reconvened the meeting.

#### 365 c Letter from Resident

A letter had been received from a resident in Malthouse Road objecting to the planning application for change of use on the car parking and the fact the cars would be visible from the top of the Recreation Ground. It was agreed a new hedge could be planted that would screen the cars. Cllr Mrs Goodworth pointed out that this would compromise the use of the ground for the annual gymkhana.

**397** i **TM/18/00008/FL:** North Down, Plaxdale Green Road, Stansted: First floor side extension and enclosure of existing tool room

After discussion, it was agreed to respond as follows:

Stansted Parish Council has no objection in principle to this application, but asks that development rights for a further garage are removed.

398 ii TM/18/00020/FL: Crabdene, Hatham Green Lane, Stansted: Proposed replacement dwelling

After discussion, it was agreed to respond as follows:

Stansted Parish Council has no objection to this application, but considers any external lighting should be minimal.

399 iii TM/18/00078/TEN: BT Radio Mast, Gravesend Road, Wrotham: Prior Telecommunications Notification: A 3dB VHF Colinear Antenna model number S.C3B manufactured by Skymasts on the existing mast

400 iv TM/18/00118/FL: Stansted Church of England Primary School, Malthouse Road, Stansted: Change of use to office/community use and associated entrance and car parking

401 v TM/18/00120/FL: Former Vigo Inn (Vigo Cottage), Grasvesend Road, Wrotham: Section 73 for the removal of condition 11 (1 bed dwelling) pursuant to planning permission TM/14/03395/FL (Change of use of the Vigo Inn Public House to two dwellings with associated residential curtilages and construction of two buildings to create 2 self-catered holiday let units)

Condition 11: The 1 bedroomed dwelling shall not be occupied other than in connection with the management of the holiday lets hereby approved in accordance with the email dated 27.05.15. Reason: To safeguard the character and amenity of the area.

After discussion it was agreed to object as follows:

Stansted Parish Council objects to this application. The condition was imposed by the Local Planning Authority for a reason and the Parish Council sees no justification why this condition should be removed. Should the Local Planning Authority be minded to approve this application and remove the condition, the Parish Council requests that all further development rights are removed. There have been several planning applications in connection with the former Vigo Inn. The property is in the Metropolitan Green Belt and the recently permitted developments have constituted additional dwellings in the Green Belt. To approve this application for removal of the condition tying Vigo Cottage to the holiday lets would add a further dwelling in the Green Belt. The Coiuncil feels there has been creeping development since the pub closed and considers enough is enough.
