### 11 QUOTATION FROM NURTUTRE LANDSCAPES FOR 2020-21 CONTRACT

The Clerk had received confirmation of the cost of works by Nurture Landscapes for 2020-21 and confirmed that there was an increase of 2% on 2019-20, as had been agreed previously for the 2020-2021 Budget.

### 12 SUPPORT FOR VULNERABLE PEOPLE IN THE PARISH

No further requests for help had been received. Parish Councillors reported that elderly and vulnerable people were receiving necessary support from families, friends and neighbours.

# 13 THRIFTWOOD CAMPING AND CARAVAN SITE

- Parish Councillors had received an email originally sent by Cllr Mrs Tisson, expressing concern that although the Thriftwood site was closed due to Covid19 restrictions, at least 50% of the sites appeared to have cars parked by them. This suggested that they were being used, either as holiday homes (not allowed under Covid19 restrictions) or as permanent residences (not allowed at the site). The implications for this regarding education, council tax, and social services were discussed at length. Cllr Bott agreed to speak informally to the owner Mr Sellers. The Clerk would write to TMBC Cllr Martin Coffin to express concerns, and also to KCC Cllr Harry Rayner with regard to social services.
- It was further noted that many trees were being cut down along a border between the camp site and farmland. Cllr Bott agreed to speak to the owner Mr Sellers, and it was agreed that the Clerk would write to Liz Guthrie at TMBC to ask if the trees had TPOs and if not could they be obtained.
- Cllr Mrs Tisson suggested that the Parish Council could arrange for new trees to be planted along the hedge to replace the but trees, and Cllr Bott agreed to speak to the owner of the adjoining farmland.

# 14 NEW NOTICE BOARDS

It was noted that the new notice boards required reinforcement to prevent the doors blowing back too far when opened in breezy weather; also that more substantial bolts were required; and that one of the doors had dropped. It was agreed the Clerk would write to Gerry Glidewell.

### 15 ZOOM SUBSCRIPTION

The Clerk reported that KALC had negotiated a special price for a Zoom Pro subscription, £7.99 instead of £11.99/12.99.

28 Cllr Mrs Falconer had kindly allowed the Parish Council to use the Zoom on her subscription, and said she was willing for this to continue in the short term.

It was agreed that this would be reviewed when / if necessary.
